PREPARATION OF INFORMATIVE AFFIDAVITS

BENEFIT TEST

Evaluation of compliance with the so-called "benefit test", a necessary condition for the deduction of the cost or expense from services received from related parties.

It requires the obligation to have the documentation and information that evidence the effective provision of the service and its nature, its real need, the costs and expenses incurred by the related supplier, as well as its allocation criteria.

MARKET RANGE STUDY (MRS)

Determination of profit margins or market prices for operations between related parties. Report detailing the methods applied and supporting documentation for compliance with the "full competition principle".

DIAGNOSIS AND PLANNING OF TRANSFER PRICING

Structuring and determination of the market value for transactions within the scope of transfer prices: loans, transfer of intangibles, exchange of goods and services, among others.

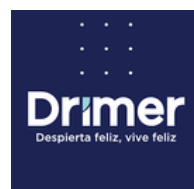
